The cancellation is final once Gas Networks Ireland sends an email accepting the cancellation of the RG Certificates. The cancellation is registered as from the requested date provided that Gas Networks Ireland has been notified of the cancellation no later than five working days before the cancellation is to become effective.

For a Proof of Origin certificate, when Gas Networks Ireland receives the cancellation request it will check that the Certificate Account Holder requesting cancellation was registered at the exit point of the beneficiary and was allocated gas in the period.

*The term Renewable Gas (RG) refers to "Renewable Natural Gas", which is gas produced from renewable non-fossil sources most commonly by anaerobic digestion of biodegradable matter and which is (or will be) prior to such gas being tendered for delivery to the Transportation System purified and upgraded to meet the applicable entry specification.
