

Terms and Conditions

Gas Networks Ireland – Science Week competition November 2022

Offer valid from 10th November 2022 until 18th November 2022.

1. Eligibility: This competition is open to children under the ages of 18 or adults under the care of a guardian, entries to be submitted by guardians aged 18 or over, who reside in the Republic of Ireland or Northern Ireland including employees of Gas Networks Ireland ('The Promoter') and its subsidiary companies, their agencies and anyone professionally connected with this promotion.

2. How to Enter: To enter guardians must send a space drawing to: sustainability@gasnetworks.ie from Friday the 11th of November 2022 up to midnight on Friday 18th November 2022.

3. The Promoter: The Promoter is Gas Networks Ireland, a company registered in Ireland under company registration number 555744.
