#### **Section D:** State Aid

The present funding is provided under the European Commission Regulation (EU) 2023/2831 of 13 December 2023 on de minimis aid.

Small amounts of State aid, up to €300,000 in any three-year period (36 months) to any one enterprise, are regarded as too small to significantly affect trade or competition in the common market. Such amounts are regarded as falling outside the category of State aid that is banned by EU State aid rules and can be awarded without notification to or clearance by the European Commission. A Member State is required to have a mechanism to track such aid (called 'de minimis aid') and to ensure that the combined amount of de minimis aid payments from all sources to one enterprise in any three-year period (36 months) respects the €300,000 ceiling.

The Applicant must therefore provide details of all other de minimis aid which has been granted to the Applicant within the past three years (36 months), pursuant to the declaration below. It should be noted that a false declaration by the Applicant, resulting in the threshold of €300,000 being exceeded, could later give rise to the aid being recovered with interest.

It should also be noted that, if GNI issues a Grant Agreement to the Applicant, the Applicant will also need to confirm that the responses provided in respect of de minimis aid in Tables 1 and 2 of the declaration below remain unchanged, or update the responses as appropriate, immediately prior to the conclusion of the Grant Agreement. The grant amount will be adjusted accordingly if there are updates.
